Graphics for Membership Directory & Website

- Submit ads and company logo in graphic format **ONLY: jpg, gif, or tiff.** (CMYK color printing)
- Do not submit graphics in PDF format. When converted to a graphic, PDF versions will lose resolution and blur.
- For best clarity, submit ads/photos/logos in **300-600 dpi** resolution. Higher resolution graphics can be reduced to size; however, enlargements from resolution below 600 dpi will blur.
- Membership Directory Graphic Sizes:
(white margins will count toward sizes)
 - **Full page = approximately 7 x 9"** (Terabyte & Gigabyte-levels only)
 - **Quarter page = approximately 4 x 5"** (Megabyte-level)
 - **Business card = approximately 2 x 3.5"** (Kilobyte-level)
 - **Profile picture = approximately 3.5 x 2"** (All levels)
